- (a) if the allocation of the NDN Application is subject to bidding, I/we\* shall be required to place a minimum bid deposit of the amount prescribed by SGNIC for the number category of the NDN Application, and also pay to SGNIC the final bid price if I/we successfully bid for the same; and
  - (b) if the allocation of the NDN Application is not subject to bidding, I/we\* shall be required to pay SGNIC the relevant minimum allocation fee prescribed by SGNIC for the number category of the NDN Application.
5. I/We\* further understand that:
- (i) Any false or inaccurate declaration made by me/my company\* will disqualify my/our\* application or render my/our\* registration to be cancelled by SGNIC;
  - (ii) SGNIC may not register or allocate the NDN Application; and
  - (iii) SGNIC may reject any application which is not in accordance with the Registrant Agreement, RPPG and/or SLG.
