  - (g) The Sponsorship shall be disbursed only after SGNIC receives and approves the duly completed Sponsorship Claims Form, including all required documents stipulated in the Sponsorship Claims Form, which is found in Annex 3 of this Letter of Offer.

6. Without prejudice to the confidentiality obligations set out in the General Terms, the Registrar shall keep the terms of the Sponsorship Documents confidential. Such information shall not be released to any third party without the prior written consent of SGNIC.

SGNIC reserves the right to amend any of the terms and conditions contained in the Sponsorship Documents from time to time as necessary and shall notify the Registrar of such amendments accordingly except that no such amendment shall affect the rights or obligations of the Registrar retrospectively.
8. We would appreciate if you can respond within 1 week from the date of this Letter of Offer, using the Acceptance Form enclosed, failing which this offer shall lapse.
